

## Privacy statement

### Personal data that we process:

All Round Balance processes personal data about you because you use our services and / or because you provide this to us yourself. Below you will find an overview of the personal data that we process:

- First and last name
- Address
- Date of birth
- Gender
- Telephone number
- E-mail address

### Special or sensitive personal data

All Round Balance processes data that are necessary for your treatment. This also includes sensitive or special personal data such as health data.

For the processing of this personal data, we ask for your permission by means of a consent form.

For the processing of personal data of persons under the age of 16, we ask for permission from their parents or guardian.

### Why we need data

All Round Balance processes your personal data for the following purposes:

- To be able to call you if this is necessary to carry out our services
- To inform you about changes to our services and products
- Processing your payment
- Send of our newsletter

### How long we store data

All Round Balance will not store your personal data for longer than is strictly necessary to achieve the purposes for which your data is collected.

The client's file is kept for a total of 15 years in accordance with the legal retention period. With the exception of the legal retention period, the clients' files will be destroyed in the event of sudden death of the therapist.

### Sharing with others

All Round Balance does not share your information with third parties without your permission and will only provide it if this is necessary for the implementation of our agreement with you or to comply with a legal obligation. With companies that process data on behalf of us, we conclude a processing agreement to ensure the same level of security and confidentiality of your data. All Round Balance remains responsible for these processes.

### **Mapping website visit**

All Round Balance uses functional, analytical and tracking cookies.

A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website.

You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information that was previously saved via the settings of your browser.
